INSTRUCUTIONS

Whenever there is a storm damage, the insured is within fifteen days after, at the latest to deliver to the Company an Account of the several articles or matters damaged or destroyed by storm with the estimated cash value on each of them respectively immediately before

the storm. When property hereby insured is only partially damaged by storm, no abandonment thereof will be allowed unless by consent of the Company or its Agents.

The Cash Value of property destroyed or damaged by the storm shall in no case exceed what would be the cost to the insured or replacing the same: and in case of the depreciation of such property from use, or otherwise, a corresponding deduction shall be made from the cost of replacement in order to ascertain the actual Cash value immediately before the loss.

N.B When the policy is subject to the average or pro rata condition, a full and exact statement of the whole value of the property within the protection of the policy or of the item or items under which the claim is made must be furnished.
