PRESS RELEASE ON LATE SUBMISSION OF 2017 AFS, Q1 AND Q2 2018 INTERIM ACCOUNTS

The Management of Standard Alliance Insurance Plc (the Company) will like to inform its Shareholders, Stakeholders and the investing public that the Company is yet to file its Audited Financial Statements for year ended 31 December 2017 (2017 AFS), within the extended due date as approved by the Nigerian Stock Exchange ("The Exchange") and as published in the Punch and Businessday newspapers of 20th February, 2018 respectively.

Consequently the Company is unable to file its Interim Unaudited Financial Statements (UFS) for the periods ended 31st March, 2018 (Q1), and 30th June, 2018 (Q2).

The Company has submitted its 2017 AFS to its Primary Regulator, the National Insurance Commission (NAICOM) and is awaiting approval before submission to The Exchange.

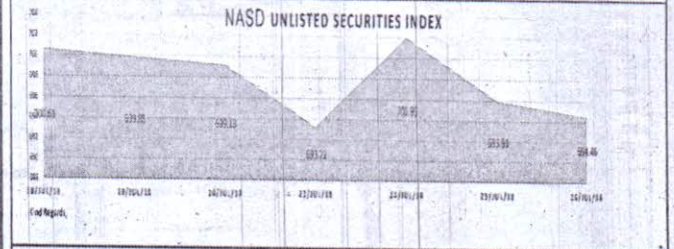

The OTC Unlisted Security Index (USI) and Market Capitalisation closed the trading day on Thursday, 25 July, 2018 with a negative movement from Wednesday, 25 July, 2018. The NASD USI and Market Capitalisation closed at 694.46 Points and N459.96 billion respectively.

Number of equities traded decreased by 90.24% from 1.04 million units to 101,231 units valued at N14.02 million in Eleven (11) deals. Negotiations focused on Five (5) out of the Thirty-eight (38) securities admitted to trade on the NASD OTC market.
